PURPOSE:

Qualifications / Eligibility:

- Legal residents of the State of Maine who are 18 years of age or older with a proposed idea or product for a for-profit business, could be just a concept or could be in beginning stages of operation.
- Not open to ongoing, established businesses.
- Business plan / idea must be the sole property of the participant and their team. Ideas that have conflicts with existing businesses/products/patents/trademarks/etc. will be disqualified.
- Uncle Henry's reserves the right to determine eligibility in its sole discretion.
- There is no guarantee of winning or receiving any set outcome for the Uncle Henry's Pitch ME Challenge. If no eligible contestants are found, no prizes will be awarded.

Timeline:

Entries Accepted July 1, 2016 through September 30, 2016. Entries must be received at the Uncle Henry's office either in hard copy or electronically by close of business on September 30, 2016.

Process:
